Dear G.W. Graham Secondary School Families,

**Re: Early Exposure Notification - Confirmed Novel Coronavirus (COVID-19) Case**

As we all know, we are in a global pandemic, and COVID is around us and in our community. We are issuing a letter to our G.W.Graham Secondary School community to provide early notification that an individual with a confirmed COVID-19 case attended G.W.Graham Secondary School on November 23, 2020.

This letter provides some context to the Fraser Health Authority's attached important information, clarifying just what has happened and how it impacts you and your family. It is key that you read this information and the attached letter, so you understand our processes. Receiving this letter does not mean you have been directly exposed to COVID-19.

First and foremost, Chilliwack School District is committed to transparency. When the Health Authorities have informed us that a positive case has been identified in our school, you will be notified. This letter is part of that notification.

Fraser Health Authority has initiated contact tracing to identify any individuals who need to self-isolate or self-monitor for symptoms. If you do not receive a phone call or letter, please continue attending school and monitoring for symptoms compatible with COVID-19 as per our District Health and Safety protocols. Students and staff must stay home even if they have the mildest symptoms.

The safety and well-being of our students, families, and staff remain our highest priority. Please be reassured that our school district will continue to implement the strict health and safety protocols we have in place so that our children and staff can continue to attend school as safely as possible.

**RE: COVID-19 NOTIFICATION**

Dear Parent,

The intent of this letter is to provide early notification of an individual confirmed to have COVID-19 at your child's school and to advise you on next steps being taken by public health. Public health is following up on this exposure according to school-based guidelines similar to those in other workplaces and community settings.

Receiving this letter does not mean you have been exposed to COVID-19. Case(s) have been isolated, and there is no direct exposure risk at this time.

An individual with COVID-19 was at your child's school **GW Graham Middle Secondary** (45955 Thomas Rd, Chilliwack, BC) on:

**November 23, 2020**

As a result, Public Health:

- has initiated contact tracing to rapidly identify any staff and students that need to self-isolate or self-monitor for symptoms.
- will continue to investigate the exposure at the school
- will only phone staff and students that public health has identified as needing to **self-isolate** for 14 days from when they were exposed.
- may send letters to staff and students who will be asked to **self-monitor** for symptoms. These staff/students may continue to attend school while monitoring for symptoms.

It is important to note that receipt of this letter does not mean you will be contacted by public health. You will not be contacted by public health unless you were directly exposed to COVID-19.

Please have your child continue to attend school and monitor for symptoms compatible to COVID-19 as per your school policies.

For privacy reasons, we cannot give out any specific details on the COVID-19 exposure other than the information provided above.

***Please continue to attend school.***

## HOW IS COVID-19 SPREAD?

This virus is spread between people by droplets. This means you need to be close enough to be exposed to saliva or mucus from the mouth, nose or throat of the infected person.

## WHAT IF YOU OR YOUR CHILD HAVE SYMPTOMS OF COVID-19?

- Isolate yourself and/or your child from others.
- Get assessed for COVID-19 as soon as possible.
- Contact 8-1-1 or your doctor to find out if you should be tested for COVID-19.
